As you are aware, this firm represents Timothy Luby, majority member of the Company. On April 21, 2010, Judge William Parsons of the Volusia Circuit Court declared that Mr. Luby has greater than 50% of the voting interests in the Company. We are still awaiting Judge Parsons' signature on the agreed order, but have enclosed the hearing transcript for your review.
