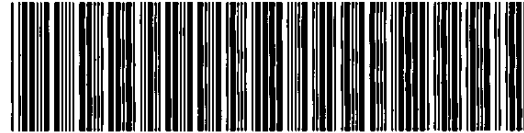

In compliance with the requirements of the laws of the State of Florida and Chapter 608, Florida Statutes., and for the purpose of forming a limited liability company, the undersigned does hereby adopt the following Articles of Organization:

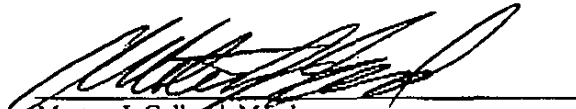
