**ARTICLES OF AMENDMENT

These Articles of Amendment of Articles of Organization of U.S. United Barge Line, LLC (the "Company"), dated as of May 24, 2012, are being duly executed and filed by the undersigned, as authorized representative, to amend the Articles of Organization of the Company pursuant to Section 608.411 of the Florida Limited Liability Company Act.

FIRST: The name of the limited liability company is U.S. United Barge Line, LLC.

SECOND: The Articles of Organization of the Company were filed with the Secretary of State of the State of Florida on November 28, 2007, and amended pursuant to the Articles of Correction of the Company and the Articles of Amendment of Articles of Organization as filed with the Secretary of State of the State of Florida on December 19, 2007 and May 23, 2012, respectively, and assigned Florida document number L07000118998 (the "Articles").

THIRD: The Articles are hereby amended by deleting in their entirety Article II, Article III and Sections 4.1 and 4.2 of the Articles and substituting in lieu thereof the following:

"ARTICLE II
