**ARTICLES OF ORGANIZATION**

**FOR**

**ARTICLE I-NAME**

The name of the Limited Liability Company is: **CASA HALWANI, L.L.C.**

**ARTICLE II-ADDRESS**

The mailing address and street of the principal office of the Limited Liability Company is: **1825 Ponce de Leon Blvd., Box 277, Coral Gables, Florida 33134.**

**ARTICLE III-DURATION**

The period of duration for the Limited Liability Company shall be perpetual.

**ARTICLE IV-MEMBER SHARES**

The Limited Liability Company is authorized to issue 1,000 shares of membership interest, which shares shall evidence the interest of the members of the Limited Liability Company, which shares shall be designated "Member Shares". The interest of the members of the Limited Liability Company shall be evidenced by the Certificate of Limited Liability Company interest issued by the Limited Liability Company and setting forth the number of Member Shares issued and outstanding in the name of such member.

**ARTICLE V-MANAGEMENT**

5.1- The Limited Liability Company has a board of managers and the business and affairs of the Limited Liability Company shall be managed by or under the direction of its board of managers. No member of the Limited Liability Company, in such capacity as a member, shall have any right or authority to act for or to bind the Limited Liability Company.

5.2- The board of managers of the Limited Liability Company shall consist of one (1) manager initially. The number of members of the board of managers may be either increased or diminished from time to time, as provided in the Regulations of the Limited Liability Company but shall never be less than one (1). Each manager shall serve until the first annual meeting of the members of the Limited Liability Company or until their successors are elected and qualify. The

**ARTICLE VI-ADMISSION OF ADDITIONAL MEMBERS**

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning a majority of the issued and outstanding Member Shares of the Limited Liability Company. In such event, the terms and conditions for the admission of additional members, together with the capital contributions required of new members, shall be determined at that time by a vote of the members owning a majority of the issued and outstanding Member Shares of Limited Liability Company. A member's interest in the Limited Liability Company may not be sold or otherwise transferred except upon the approval of members owning a majority of the issued and outstanding Member Shares of the Limited Liability Company.

**ARTICLE VII-MEMBERS RIGHT TO CONTINUE BUSINESS**

The remaining members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company, upon the death, retirement, resignation, expulsion, bankruptcy, of dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company, upon the approval of members owning a majority of the issued and outstanding Members Shares of the Limited Liability Company.

**ARTICLE VIII-OFFICERS**

The managers shall hold those offices and have those responsibilities accorded to them by the members of the Limited Liability Company, as set forth in the Regulations of the Limited Liability Company.

**ARTICLE IX-AMENDMENT OF ARTICLES OF ORGANIZATION**

The Limited Liability Company reserves the right to amend or repeat any provisions contained in these Articles of Organization, or any amendment hereto, and any right conferred upon the members is subject to this reservation.


**ARTICLE X-INDEMNIFICATION**


