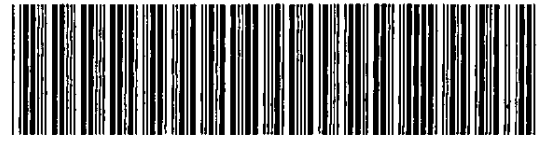

ARTICLE VI: MANAGEMENT

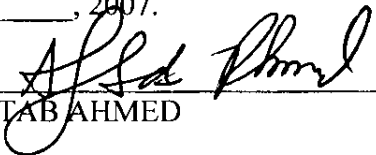

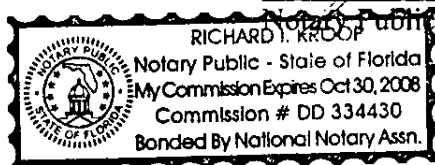

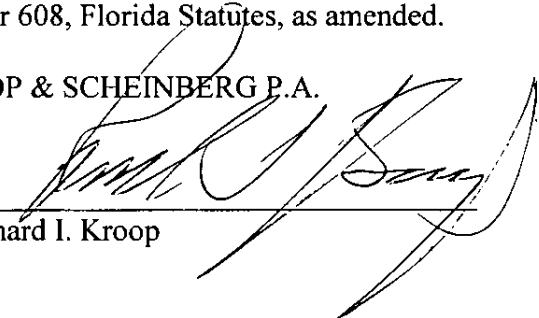
