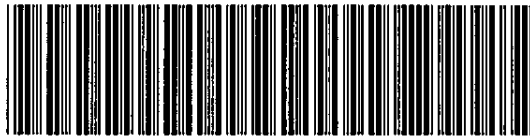

The undersigned, a natural person, does hereby form a Limited Liability Company under Florida Statutes §608, and other laws of the State of Florida.

**ARTICLE 1
NAME**

The name of this limited liability company is F & B GAS HOLDINGS, LLC, referred to in these Articles of Organization as the "COMPANY".

**ARTICLE 2
REGISTERED OFFICE AND AGENT**

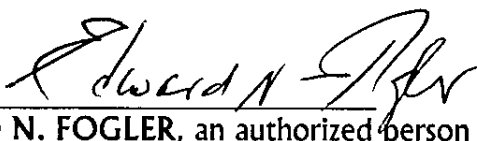
