**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
FLACTEC, LLC
a Florida limited liability company**

Pursuant to the provisions of section 608.411, Florida Statutes, FLACTEC, LLC adopts the following amendment to its Articles of Organization:

FIRST: The Articles of Organization of FLACTEC, LLC, a Florida limited liability company (the "Company"), were filed on November 30, 2007 and assigned Document Number L07000119650.

SECOND: Article II of the Articles of Organization is amended, in its entirety, to read as follows:

"ARTICLE II

THIRD: Article V of the Articles of Organization is amended, in its entirety, to read as follows:

"ARTICLE V

The Company will be manager-managed in accordance with the terms of its Operating Agreement."
