ARTICLES OF ORGANIZATION

With respect to the Articles of Organization of PM RADIOLOGY, P.L. (the "Limited Liability Company"), which were filed with the Florida Department of State on November 30, 2007, the undersigned, constituting all of the members of the Limited Liability Company, hereby confirm that the Members of the Company have approved the following Amended and Restated Articles of Organization of the Limited Liability Company in accordance with the provisions of Section 605.0202, Florida Statutes, which upon filing with the Florida Department of State, as of the effective date thereof, will supplant and replace in their entirety the Articles of Organization filed on November 30, 2007, and any and all amendments thereto filed prior to the date hereof.

ARTICLE I - Name
