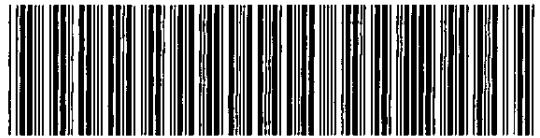

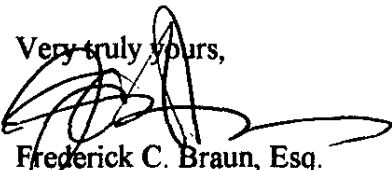

## **ARTICLES OF ORGANIZATION**

**OF**

### **PMEP HOLDINGS, LLC**

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

#### **ARTICLE I - NAME**

The name of the Limited Liability Company ("Company") shall be PMEPM HOLDINGS, LLC.

#### **ARTICLE II - PRINCIPAL PLACE OF BUSINESS**

The address of the principal place of business of this Company shall be 11349 Mainsail Court, Wellington, Florida 33467, and the mailing address of the Company shall be the same.

## ARTICLE VI - CONTINUATION OF COMPANY

Except as otherwise provided in the operating agreement adopted by the members, the remaining members of this Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any event that terminates the continual membership of a member in the limited liability company, upon the vote of the remaining members owning at least sixty (60%) percent of the voting membership interests.

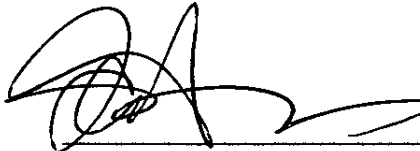
