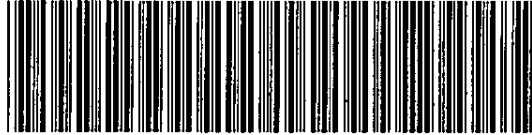

ARTICLES OF ORGANIZATION
OF


STATEMENT OF
