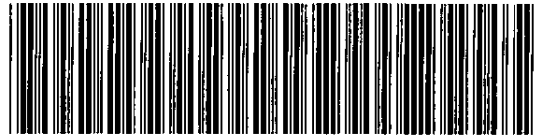



Name

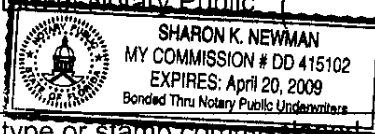
