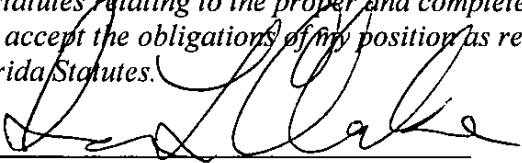

ARTICLE IX – MEMBERS LIMITED LIABILITY

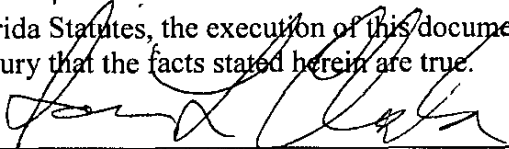
The liability of the members shall be limited as provided under the laws of the Florida Limited Liability statutes.

ARTICLE X – MEMBER(S) AS AGENTS

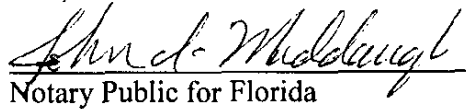
