Jeffrey S. Grove, D.O. (Grove) is the sole Member and Managing Member of Brian J. Bixler, M.D., P.L., a Florida professional limited liability company. Grove has authority to file these Articles of Dissolution of Brian J. Bixler, M.D., P.L. (Bixler, P.L.) and states:

1. On June 8, 2011, Brian J. Bixler, M.D. (Bixler), the sole member of Bixler, P.L. assigned all of his membership interests to Grove. Bixler resigned as Registered Agent and Managing Member of Bixler, P.L. At the same, Grove elected himself as Managing Member and Resident Agent of Bixler, P.L.

2. Bixler, P.L. was administratively dissolved by the Florida Division of Corporations on September 26, 2014.

3. Bixler, P.L. no longer functions as a going business and has not functioned as a going business since September 26, 2014.

4. Grove consents to the dissolution of Bixler, P.L., which was organized under Chapter 621 of Florida Statutes. Section 621.13 states that Chapter 605 is applicable to a Limited Liability Company organized under Chapter 621.

5. Florida Statute 605.701 states that a Limited Liability Company is dissolved and its activities and affairs must be wound up on the occurrence of the consent of all of the Members to dissolution. Jeffrey Grove, the sole Member and Manager, on August 4, 2015, signs these Articles and consents to the dissolution of Brian J. Bixler, M.D., P.L. effective with the filing of these Articles.
