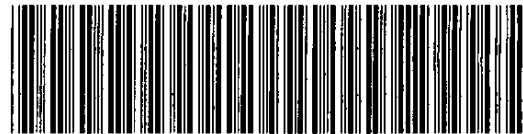


This limited liability company is organized for the purpose of transacting any and all lawful business, including acting as Trustee.
