FIRST: The name and address of this Company is **MEDICATION CONSULTANTS, LLC**, 4095 State Road 7, Suite L-208, Wellington, Florida 33449.

SECOND: The date of the adoption of these Articles of Dissolution is 24 April 2009.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421.
