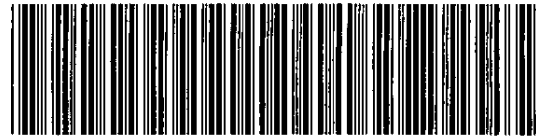

ARTICLES OF ORGANIZATION
OF
HUNT'S SURVEYING AND MAPPING, PLLC

The undersigned, a licensed Florida surveyor, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 621, to provide professional surveying and mapping services, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the professional limited liability company shall be HUNT'S SURVEYING AND MAPPING, PLLC ("company").

ARTICLE II -- ADDRESS

The mailing address of the company is P O Box 283 Bushnell, Florida 33513 and the street address of the principal office of the company is 1315 West C-476 Bushnell, Fl 33513.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.


ARTICLE IV -- REGISTERED OFFICE AND AGENT

Pursuant to Fla. Stat. Section 608.415 or 608.507, the undersigned limited liability company submits the following statement to designate a registered office and registered agent in the State of Florida:

The name of the Limited Liability Company is HUNT'S SURVEYING AND MAPPING, PLLC and the name and street address of the registered agent of the company in the state of Florida are Douglas Hunt 1315 West C-476 Bushnell, Fl 33513.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and I am familiar with and accept the obligations of my position as registered agent.

ARTICLE V -- ADMISSION OF NEW MEMBERS

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


ARTICLE VI -- MEMBERS' RIGHT TO CONTINUE BUSINESS

ARTICLE VII -- MANAGEMENT


The company shall be managed by its members and is, therefore, a member-managed company.
