## ARTICLES OF ORGANIZATION OF HUNT'S SURVEYING AND MAPPING, PLLC

The undersigned, a licensed Florida surveyor, for the purpose of forming a professional limited liability company under whe Florida Limited Liability Company Act, F.S. Chapter 621, to provide professional surveying and mapping services, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME
