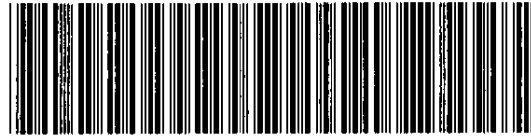

SECOND: The Articles of Organization were filed on December 5, 2007, and assigned document number L07000121015.


THIRD: The following amendment to the Articles of Organization were adopted by the limited liability company:
