



ARTICLES OF ORGANIZATION OF

JLC CONSTRUCTION, LLC

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a member or an authorized representative of a member of JLC Construction, LLC, hereby forms a limited liability company.

Article 1 - Name

The name of the limited liability company is JLC Construction, LLC (the "Company").

Article 2 - Duration

The duration of the Company shall be from the date of creation to and until December 31, 2025, unless sooner terminated or extended by agreement of the Members.

Article 3 - Initial Principal Office

The mailing address and the street address of the initial principal office of the Company shall be 7873 Camp Mack Road, Lake Wales, Florida 33898.

Article 4 - Registered Agent






