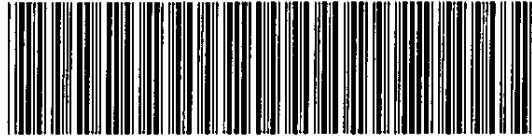

**Management**

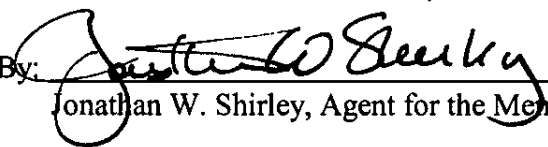

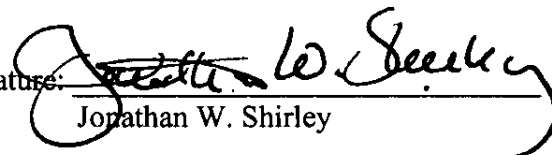
**ARTICLE VI**
