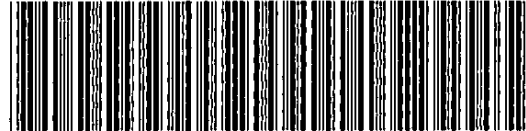

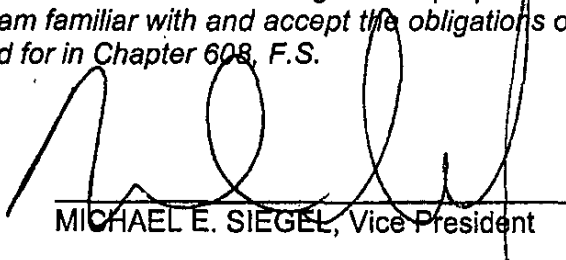

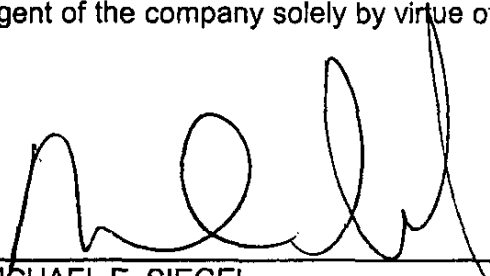
ARTICLE IV - MANAGEMENT
