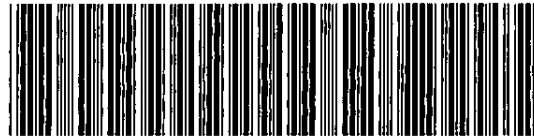

## **ARTICLES OF ORGANIZATION**

The undersigned, acting as a member for the purpose of forming JOSE AUGUSTINE, M.D., P.L. 
