**ARTICLE I - NAME**

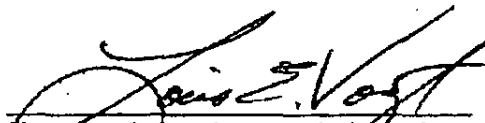
The name of this limited liability company is BRM HERITAGE WHITEHILL ESTATES I, LLC (the "Company").

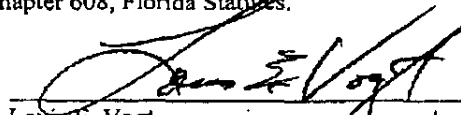
