**ARTICLES OF ORGANIZATION
OF
MAVERICK INVESTMENT MANAGEMEMNT LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Maverick Investment Management LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 300 41 Street, Suite 201-A, Miami Beach, Florida 33140.

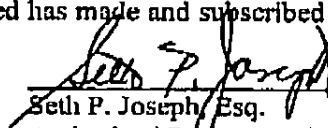
ARTICLE IV. DURATION

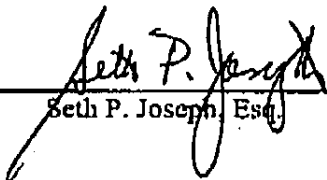
