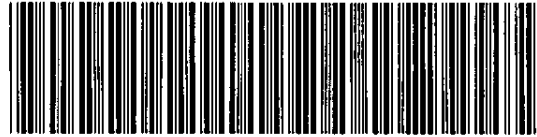

Felix Filenger of 4100 NW 3rd Court, Suite 205, Plantation, Florida 33317, shall be continue to be Managing Member of the Company.

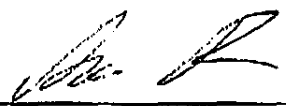

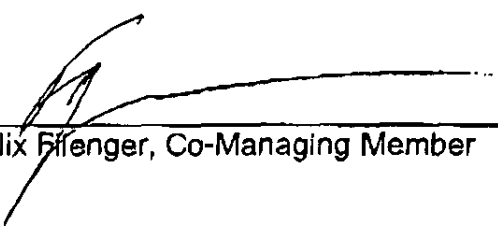
