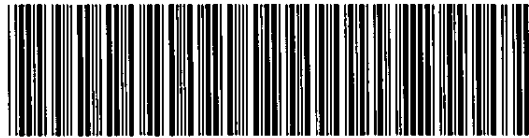

2. The following Amendment to the Articles of Organization were adopted by the Company:

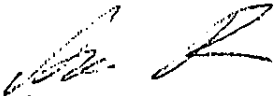

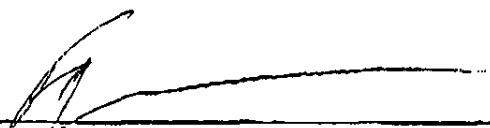
