**ARTICLES OF ORGANIZATION
OF
PAPA GATOR AIR, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be Papa Gator Air, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 1006 SE 4th Street, Gainesville, Florida 32601.

**ARTICLE II
PURPOSES AND POWERS**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

MANAGER


