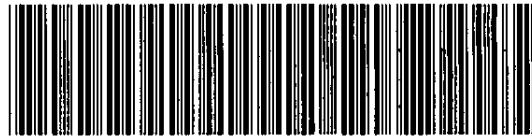


The Articles of Organization for this single member limited liability company were filed with the Florida Department of State on December 13, 2007, and were assigned Florida document number L07000123585.
