

**ARTICLES OF ORGANIZATION OF
LAKESIDE APPRAISAL SERVICES, LLC.**

**ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS**

**ARTICLE II


These Articles may be amended by a vote of a majority in interest of the members.


