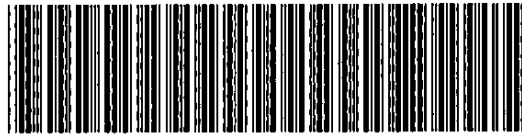

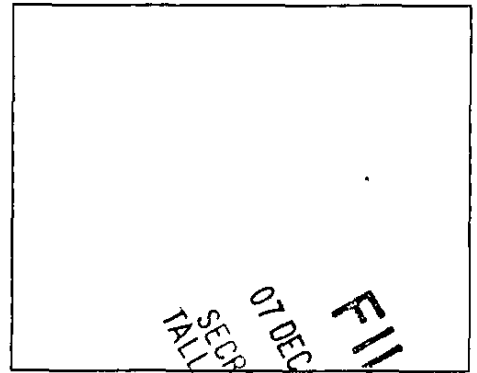

ARTICLE V


The existence of the limited liability company shall be deemed to commence upon the filing of these Articles with the Florida Department of State.
