ARTICLES OF ORGANIZATION OF PANACHDESAI, LLC, a Florida Limited Liability Company



The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company is **PANACHDESAI**, **LLC**, a Florida limited liability company (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 447 1st Avenue North Naples, Florida 34102.
