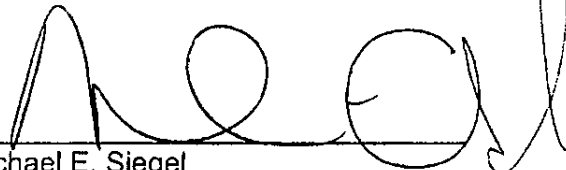
#### **ARTICLE IV - MANAGEMENT**
