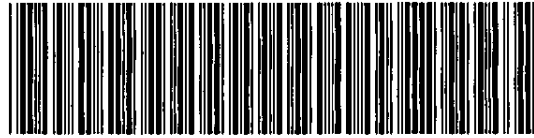

Name**

Address**



ARTICLE V Management

The management of the Company is vested in Managers who may or may not be Members of the Company. The powers and duties of the Managers are as set forth in the Company's Operating Agreement. Each Manager will serve until the first annual meeting of the Members or until his/her successor is elected and qualified. Initially, there shall be one Manager of the Company. The initial Manager of Omni Commercial Construction of NW FLA, LLC is:

Unless expressly provided in the Company's Operating Agreement, no Member who is not a Manager has any authority to act for, or to undertake or assume any obligation, debt, duty or responsibility on behalf of any other Member of the Company.

ARTICLE VI Admission of New Members

The Members may admit to the Company Additional Member(s) to share in the profits, losses, available cash flow, and ownership of assets of the Company on such terms as are determined by Members then holding a majority interest in the Company. Admission of any Additional Member(s) requires the written consent of all Members. Any such Additional Members will be allocated gain, loss, income, or expense by the method provided in the Company's Operating Agreement.

ARTICLE VII Continuation of Business

The death, retirement, resignation, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company shall not dissolve the Company.


ARTICLE VIII Amendment of the Articles


These Articles may be altered, amended, or repealed in whole or in part by vote of Members then holding one hundred percent (100%) of the total interest in the Company, provided that any such changes shall be consistent with the laws of Florida which define, limit or regulate the powers of the Company or the Members of the Company. An amendment shall become and be taken as part of these Articles of Organization upon its filing with the Florida Department of State.


ARTICLE IX
Indemnity

To the fullest extent permitted by the laws of Florida, as the same may be from time to time amended, but subject to all restrictions set forth therein, the Company shall indemnify, hold harmless, and advance expenses to any person, his or her heirs, personal representative, executor, administrator or guardian who was or is a party to any proceeding, as defined in the statutes, by reason of the fact that he or she was a Member or Manger of the Company, against liability as defined in the Operating Agreement, expenses as defined in the Operating Agreement and amounts paid in settlement incurred in connection with such proceeding, including any appeal thereof.
