The members may admit additional members with the written consent of each member.

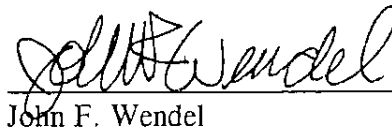
ARTICLE VI.

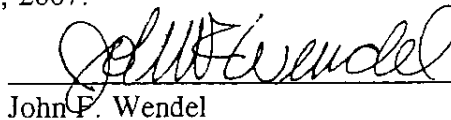
