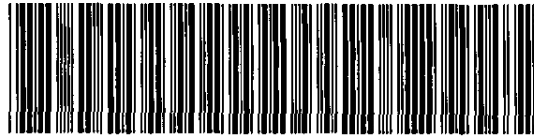

The period of duration for the Limited Liability Company shall be: Perpetual.


ARTICLE VI - Admission of Additional Members:
