

#### ARTICLES OF ORGANIZATION OF TOOJAY'S OF WEST BOCA, L.L.C.

OT OF CHARLES OF STATE The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE I --- NAME

The name of the limited liability company shall be TooJay's of West Boca, L.L.C. ("Company").

#### ARTICLE II — ADDRESS

The mailing address and street address of the principal office of the Company shall be 3654 Georgia Avenue, West Palm Beach, Florida 33405.
