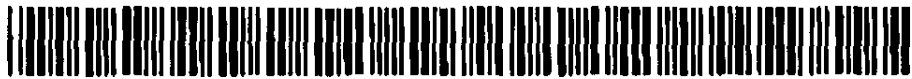

The name of the limited liability company is: LMC Edgewood Plaza, LLC.


ARTICLE II. ADDRESS
