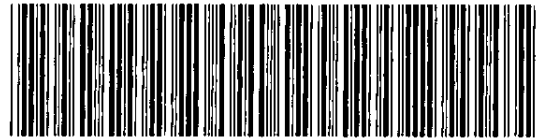

### ARTICLE 1 - NAME

The name of the limited liability company shall be **PDD SECURITIES AND PROPERTY, LLC** ("Company").

### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 4201 North Ocean Drive, #605, Hollywood, Florida 33019 and the mailing address shall be the same.

### ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective January 1, 2008.

**ARTICLE 7 - ADMISSION OF NEW MEMBERS**




