**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF**

BOGGY CREEK LAND HOLDING, LLC

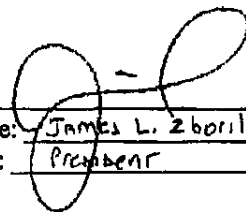
The undersigned, an authorized officer of BOGGY CREEK LAND HOLDING, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The name of the Company is BOGGY CREEK LAND HOLDING, LLC.
2. The date of filing of the original Articles of Organization of the Company was December 19, 2007, document number L07000125640.
3. The Articles of Organization of the Company are amended by deleting Article IV, entitled "Management," in its entirety and inserting the following section in its place and stead:

"ARTICLE IV – Management:

The Company is to be managed by its Member(s), unless and until one or more managers are appointed in accordance with the Operating Agreement of the Company, in which case the Company shall be managed by one or more managers. The managers shall be elected as described in the Operating Agreement."
