**ARTICLE IV- MANAGEMENT**


Authority to contract and bind the limited liability company is given to a board, with managers able to execute contracts only upon the approval of the majority votes of the board.




#### ARTICLE V- AMISSION OF ADDITIONAL MEMBERS


