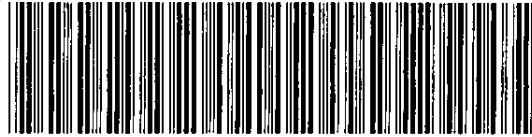

**ARTIVCLE IV – MANAGEMENT**

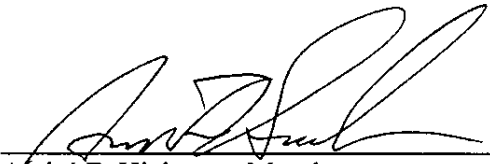

The effective date of these Articles of Organization, and the commencement of the existence of the Company, shall be the date of filing these Articles of Organization with the Florida Department of State.

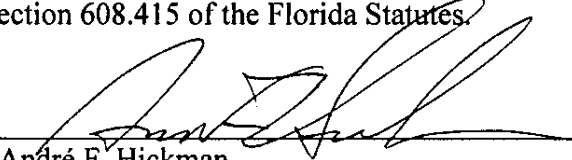
