The name of the limited liability company is: Germany Family, LLC.

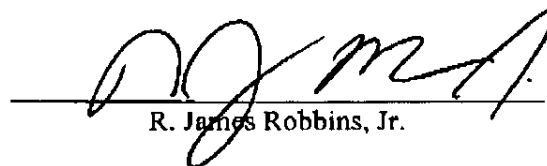
**ARTICLE II. ADDRESS**

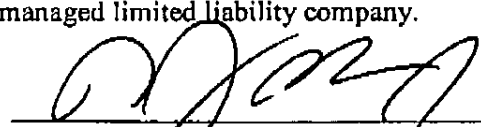
