ARTICLE I - NAME

The name of the limited liability company shall be George Mouriz Enterprises, L.L.C.

ARTICLE II - ADDRESS

ARTICLE III - DURATION

ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution or a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of the remaining members.

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
