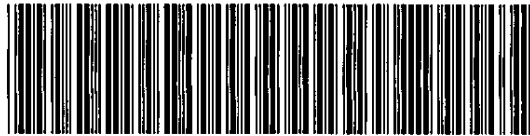

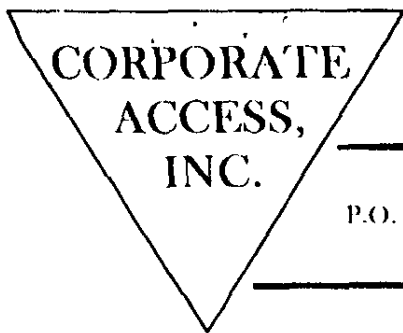

ARTICLE II - PRINCIPAL OFFICE




