ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company, under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME
