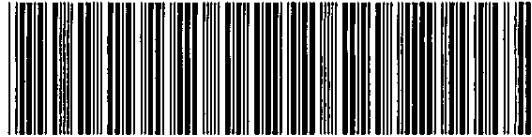

ARTICLES OF ORGANIZATION

OF

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I - NAME

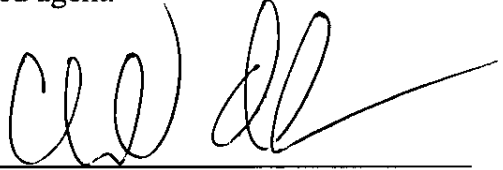
