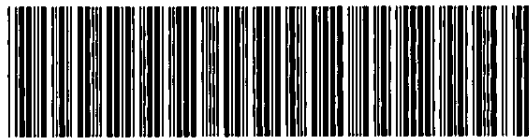

1. ARTICLES OF ORGANIZATION.

ARTICLE I
NAME

The name of the Limited Liability Company is as follows:

CANTON COVE, LLC

ARTICLE II
ADDRESS


ARTICLE VIII
