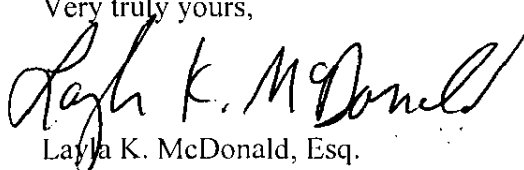
Enclosed please find original Articles of Organization for PROFOUND STILLNESS, LLC.

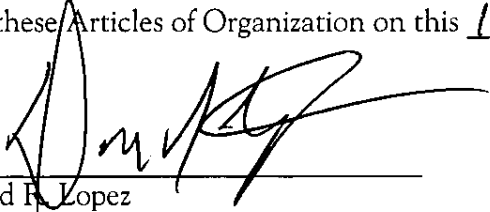
