# ARTICLES OF ORGANIZATION OF BRILLIANT & MEISTER, P.L.

#### **ARTICLE I - Name**

The name of the professional limited liability company is Brilliant & Meister, P.L. (the "Company").

#### **ARTICLE II - Address**
