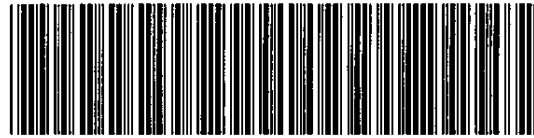


Dear Ms. Tablock:

I spoke with you on the phone on May 7, 2009 regarding the conversion of Florida LLC, Jennings Cobble, LLC, to a Tennessee LLC. As you are aware, we have previously filed a Certificate of Conversion and Articles of Organization with the Tennessee Secretary of State. The effective date of the conversion in Tennessee was April 23, 2009.
